Re: EGM of Interbrew Plc (the "Company") on 26 March 2021 has approved exceptional dividend and share premium account reduction

The Board of Directors of the Company announces that the EGM of the shareholders of the Company held today, the 26 March 2021, has approved (i) an exceptional dividend of € 427,500,000, - (lower than the intended €431.7 million figure announced on 26 February 2021 due to a subsequent reduction of the retained earnings of the Company) -, and (ii) a share premium account reduction of € 357,932,250 by way of reimbursement to shareholders.

The above corporate actions provide a dividend of \in 3.67 per share and a share premium reimbursement of \in 3.07 per share.

The shareholders entitled to the above amounts shall be the shareholders registered in the shareholders' register on 26 March 2021.

The payment of the dividend is expected to occur as soon as practicable in the following weeks. Under the Cypriot corporate law, the share premium account reduction requires a Cypriot court confirmation before the payment of the share premium reimbursement can occur. It is currently expected that such payment would occur in the course of May 2021.
